As a key advocacy groups on the Sunshine Coast, we are seeking your views on public transport and housing densification in the region. Please be advised your responses will be collated and made public as we believe all voters should be aware of your position on these two key issues prior to voting. No response will be taken to mean you agree with the following:

- 1) The current Department of Transport and Main Roads (TMR) Southern Sunshine Coast Public transport strategy and their decision to proceed with Rapid Bus Transit in a dedicated lane along our coastal strip.
- 2) The current Sunshine Coast Regional Council plan to house the large majority of the future population growth out to 2041, in the Coastal Corridor between Maroochydore and Caloundra.

4 What will you do to improve public transport now?

Response:

We are concerned that a rapid transport system is not being actioned. A rapid bus transit system requires a sufficient dedicated right of way be created, and therein lies a problem and a challenge that we will immediately tackle to ensure its success.

We will lobby for the State to take a more immediate role in improving the current public transport system. We would meet with the private operators to see how they can improve. We would investigate on-demand public transport for low density areas, for example in The Hinterland and west of the Bruce Highway, and the scope for greater opportunity for active transport and innovative transport solutions that incorporate technology.

5 What do you think should be the priority for better public transport in the future?

Response:

Better public transport that continues to attract a very small percentage of patrons does not equate with better public transport. The priority must be to enhance the attractiveness of public transport to encourage people to choose active transport or public transport before their car. This will be a priority for us.

Response:

Council does not put people anywhere. People choose where they live based on the attractiveness of an area, availability and affordability. We will advocate enhancement of other locations and areas, with a focus not to continue to expand the current urban footprint.

We understand and agree with the current height limits - "high-rise" means something different to everyone and does not advance a discussion that requires clarity and focus.
